The organization's main focus is maintaining and expanding a museum and art gallery dedicated to Western art. This facility is open to the public, serving as a crucial community resource. Besides displaying a permanent collection, the organization hosts events like student art workshops, exhibitions with guest artists, and public events to engage the community. These efforts aim to raise awareness and appreciation for the local Western heritage, emphasizing the importance of visual and performing arts in preserving and celebrating the region's cultural legacy. In addition, the organization volunteers maintain a botanical garden on the museum grounds with over 800 specimens of arid environment plants which is continuously expanding and it houses the Wieghorst familys first home in El Cajon, CA. The house was moved from its original location about a mile from the museum in 1997 and is the centerpiece of the botanical garden. Open house tours provide an opportunity for patrons to observe how Olaf and his family lived when they first moved to El Cajon from New York in 1946. The house is over 90 years old and is a designated historic landmark. The museum volunteers care for and maintain this structure.
